The Honorable Judges Of The Sald Court: Your orators complain and say:--First.--That they were on the seventh day of July, 1879, duly elected trustees of the "Seventh Day Baptists of Ephrata," and as such, by virtue of the act of incorporation of said religious society, approved the twentyfirst day of February, 1814, have full and exclusive power to manage the business of the said society pertaining to all matters of a secular character, "as to the land and real estate belonging to the same," "to receive the rents, issues, and profits therefrom," "and shall also have power to bring suits as trustees (95) aforesaid for any real or personal estate, and to receive all debts or sums of money due to the society or to any other in trust for them." Second.--That it is provided in the said act of incorporation " that before the said trustees shall act in the premises they shall respectively become bound by bond or recognizance to the Commonwealth of Pennsylvania in such sum and with such security as shall be approved by the Orphans' Court of Lancaster county, conditioned for the faithful execution of the trust." Third.--That on the sixteenth day of August, 1879, they presented their certificate of election to the Orphans' Court of Lancaster county, together with their bond as trustees in the sum of three thousand dollars, and prayed the court to approve the same as is provided for in the said act of incorporation. Fourth.--That after a full hearing of the case the Orphans' Court...
